PROPOSAL 2

RESOLVED, That the Board of Education of the Township of Frankford, in the County of Sussex, New Jersey shall (A) undertake the following improvements to Frankford School located at 2 Pines Road in the School District (the "Project"): (1) renovations (the "Renovations") consisting of installation of tile floors in the original portion of the building, roof repairs and resurfacing and reconstruction of bathrooms (including handicapped-access improvements); and (2) replacement of classroom and other doors in the original portion of the building (the "Door Replacement"); (B) expend therefore not exceeding \$1,296,205; and (C) issue bonds or notes of the School District for the local share of the Project in the principal amount not exceeding \$777,723. A grant in the maximum amount of \$518,482 (representing 40% of the final eligible costs of the Project) for the State of New Jersey’s share of the Project has been approved by the Commissioner of Education (the "Commissioner") based upon the

determination by the Commissioner that the maximum final eligible costs of the Project are \$1,296,205. In the event the State grant is not made, is delayed or is reduced, the School District is authorized to issue bonds or notes in a principal amount not exceeding the total expenditure authorized in (B) above of \$1,296,205. The \$777,723 local share of the Project has been preliminarily allocated by the Commissioner as follows: Renovations project - \$716,885; and Door Replacement project - \$60,838. The School District may transfer a portion of the local share of one project to another under circumstances permitted by statute. The \$1,296,205 final eligible costs of the Project have been preliminarily allocated by the Commissioner as follows: Renovations project - \$1,194,809; and Door Replacement project - \$101,396.
